

TAPTAB TERMS OF USE

By accepting our terms and conditions, you, as the Data Subject, agree and freely consent to the collection and processing of your personal information and data (the "Data") for marketing purposes by TapTab and its advertising partners.

Because your security is our primary concern, TapTab assures you that TapTab continually implements measures to ensure the safety and protection of your Data.

We, at TapTab, adhere to the best security practices by using different tools, methods, and processes to protect your Data.

In line with our commitment to service, we wish to inform you that you have the right to object, at any time, to the collection and processing of your Data. However, consent shall be necessary for you to avail of the promos and incentives provided by TapTab.

Once consent is given, you, the Data Subject, shall also have the right to access the Data given, and such access shall be easy as well as "data portable", meaning that the Data can be electronically stored and copied at any time.

The Data Subject shall also be entitled to correct and rectify any mistakes or misrepresentations, if any.

You, as the Data Subject, shall also have the right to withdraw your consent at any time by directly emailing TapTab at Taptab@unitedneon.com. However, such withdrawal shall disqualify you from the promos and incentives provided by TapTab.

Should the Data Subject suffer damages from our misuse of your Data, the Data Subject shall have the right to file for damages and escalate the matter with the National Privacy Commission.

Note that by participating and continued participation in TapTab, you agree to be bound by the TapTab Terms and Conditions. Further, you understand and acknowledge that the information disclosed in the membership form as well as information obtained in the course of TapTab, both of which include personal information, are collected, processed and stored in an automated UTASI-managed member data base system and/or in the member data base system of its affiliates and/or authorized third parties, and which shall be used and administered solely by UTASI, and its said affiliate companies and authorized third parties in connection with the implementation and enhancements of TapTab.

You give consent to UTASI's and its directors, officers, employees, advisers, agents and representatives' (a) collection, processing, storage and use of personal information; and (b) outsourcing of the collection, processing, storage and use of personal information to service providers whether within or outside the Philippines.

Moreover, your continued participation constitutes your express consent under the applicable confidentiality and data privacy law/s of the Philippines, and that you agree to hold UTASI and relevant parties free and harmless from any and all liabilities, claims, damages and suits of whatever kind and nature that may arise in connection with the implementation and compliance with the authorization you have conferred.

The foregoing consent shall continue for the duration of and shall survive the termination of your participation in TapTab. The foregoing is without prejudice to your right to reasonable access to, upon demand, and correction of your personal information, as well as your right to lodge a complaint before the National Privacy Commission, under Section 16 of the Data Privacy Act.

You likewise agree that the information referred to in this section may be disclosed to any of UTASI-authorized affiliates and third parties for any purposes that may include improving TapTab. For these purposes also, UTASI and its authorized affiliates shall store your personal information, as defined under Section 3 (g) of the Data Privacy Act, within five (5) years from your disclosure.
